Marioli is a family owned Mexican eatery and taqueria, tucked away behind the Starbucks off of StoneOak parkway. As you park, you immediately observe the outdoor grill and trompo for the al pastor. Inside, this neighborhood restaurant offers a cas-

ual family-friendly ambience with a wide variety of traditional Mexican dining options, to include tacos bistec, al pastor, cohinita pibil, cerviche, enchiladas, salads, tortas, posole and artesian bakery. A chef case also offers a wide selection of Mexican delicacies to go. In order to encourage a family atmosphere, Marioli's offers a selection of beer, wine, sangria, and jarritos.

On a recent Saturday visit, my husband and I began our meal with an order of mariachis. Mariachis are corn tortillitas topped with al pastor, chicharron de queso, and the best salsa in San Antonio. We then tried the tacos bistec and al pastor with the habanero salsa. They were so good that we were compelled to have seconds, and then thirds. With our meal we enjoyed a carafe of clerico (sangria blanco). On our next visit I plan to try the chilaquiles; which is a dish of shredded chicken, melted cheese, cream and crispy



tortillas drenched in red or green salsa.

As we dined, we couldn't help but notice a couple arriving directly from the airport after arriving from Mexico City. The couple supported my husband's claim that Marioli rivals any Mexican eatery in Monterrey and Mexico City. After learning that the owner attended the prestigious French Cordon Bleu Culinary School in Mexico City, Marioli's excellent food and popularity are not surprising.
