She has such big, beautiful eyes; it pained me to see them well-up with tears. It was much easier to hug her and let the tears run down my back. I clutched onto her as if letting go meant letting go of life itself.

I know my appearance can be startling. Thus, that is one reason I do not go out much. However, the major reason I don't go past my front door is I have illnesses that keep me on the run to the bathroom with either diarrhea or vomiting, make me stutter, zap me of my energy, and, if I do get a good day, cause me to take about eight hours just to get presentable, not even pretty.

Jay has been suggesting I re-connect with my sisters at the BCWBA for a while; however, as you can see, I have been hesitant. Heck, I was just in the NE Methodist Cardiac ICU ward two weeks ago for a major heart problem!! So, when not in the hospital, I stay home, never knowing when my heart will fail; always praying my stomach will prevail. I also have some unnamed gastroenterological malady that caused me to lose 90+ pounds in five months – I now wear a size 00, 0, 1, or 2, depending on the designer. I know, a dream for most ladies, a nightmare for my husband who did NOT marry a toothpick, let us just say.

I hadn't wanted to go to any event where lots of people were because I don't like being a toothpick. It's not my "dream weight" and "I am not happy about it." But my hubby, Jay, said, "Look, they are your friends. They love you. You need to see them."

Jay was right. You all were wonderful! You wonderful women who befriended me that first day Cynthia Glass Bivins gave me a seat at her firm's table (Rosa Cabezas--Gill was President), Pam Huff won the Young Belva Lockwood, and so many fantastic women made it a point to come over and introduce themselves to me; I who had yet to sit for the bar exam; I who had no family in Texas but my military hubby who had just been assigned here; I who soon adopted two beautiful baby boys and learned bloodlines are not the only way to define family.

I have viral cardiomyopathy. I will die from it. But until that day, I will be comforted by the hugs of my amazing BCWBA family for I have come home to be with them again. Can I get an Amen?
