Thanks to amendments to the BCWB Association and Foundation Bylaws passed by this year's Board, we are gearing up for our first electronic ballot to elect BCWB's 2015 Officers and Directors! Keep an eye on your email in early November for a link to a Survey Monkey ballot. All members in good standing will receive a link to the ballot, each member can only vote once, and all votes



are completely anonymous—just like with our previous paper ballots. The ballot will include photos and background information on each of the candidates up for election, but if you're looking to get a head start, the same information is below. At our November 4th luncheon, I will solicit final Director nominations from the floor, and then all nominations will close.

Candidate for President-Elect

La Panaderia opened its doors this past April. I stepped into the bakery for the first time last weekend. I've been back multiple times since to get my carb "fix." The concha de chocolate is a mild chocolate wafer crusted bun wrapped around a soft center. The pan de muertos is light and dusted with sugar, yet not too sweet – perfect with the cappuccino. For breakfast one day, I chose the telera for my chorizo and egg sandwich. The bread was toasted and crusty but chewy. Although I was full, I ordered a strawberry topped caramel cream layered puff pastry. Everything was delicious.

David Caceres and his brother, Jose, decided to open their little bakery in San Antonio after researching many other possible cities around the country. David studied baking at La Cordon Bleu in Paris and continued his practice at the San Francisco Baking Institute. He has an incredible knowledge of the history of breads in Mexico which developed through Native American, Spanish, French and Italian influences. He spoke of the 24-72 hours of rise time in the breads at La Panaderia which results in their crispy crust and moist chewy interior. He reminisced about how his brother, Jose, used to ride his bicycle through the streets of Mexico selling the breads that his mother baked: warm, fresh and straight from the oven. La Panaderia has an old fashion bike hanging on its walls; its logo is a person riding a bike with a basket on his head.

If you are a sucker for good pastries and breads, I encourage you to drop by La Panaderia for a bite and a delicious cup of cappuccino. Feel free to justify your carb intake as a sacrifice for the worthwhile support of a growing family business. I do.

In accordance with Section 11.03 of the then current Bylaws and Section 22.102 of the TBOC, the Board of Directors of BCWBA and BCWBF voted to approve the Amended and Restated Bylaws of each corporation on September 9, 2014. The Amended and Restated Bylaws are tailored to reflect the distinct missions and goals of each corporation and to bring the governing documents to date. Notably, the amendments included updating the Bylaws to reflect the ability for members to vote electronically. It also revised the language of the Bylaws to allow for up to one Associate Member to sit on the Board and to permit the Board to award lifetime membership to honorary members who have made significant contributions to the legal community.
