

### Book Review: The Trespasser

The Trespasser by Tana French is the sixth book in the Dublin Murder Squad series. Unlike many crime serials, the main character in the Dublin Murder Squad isn't a seasoned detective, but rather the Murder Squad itself. Each book focuses on a different detective, who has played a secondary role in a prior novel in the series. Tana French spends each novel diving into the depths of the lead detective's character, which inevitably shapes the detective's approach to the investigation, interaction with witnesses, and ultimately, the detective's role in the Squad. The nice thing in French's approach is that there's really no harm in picking up any one of the books in the series out of order. She's known for having strong female characters, which is always a bonus in a genre that often lacks nonvictim female characters.

In Book 6, our focus is on Antoinette Conway and Stephen Moran-the two newest additions to the Murder Squad. Conway is abrasive, to say the least. In the Squad, she faces interference with her investigations, sexual harassment, and what most employment lawyers would describe as a hostile work environment. Conway and Moran spend much of their days covering domestic battery incidents, but are chomping at the bit to grab a juicy case to shore up their place in the Squad. The Tres*passer* follows their investigation of the Aislinn Murray case, an apparent domestic assault gone wrong. Conway's (excusable) distrust of her fellow officers runs rampant through the novel, muddying the waters at every turn.

I've thoroughly enjoyed this series and I was eager to snap this book up. I struggled to get into this one, though, because I found Conway so off putting and hard to like. However, the case takes Conway on a journey, leaving her both more destabilized and eventually less guarded. Another thing I enjoyed was the fact that French could have been lazy and left the victim a paper doll of sorts, but she does the hard work of (slowly) crafting a backstory that is as important as Conway's story. Bottom line: I enjoyed The Trespasser, but it was not my favorite of French's books.
