

BS: I was wondering about that full page spread on the cover of SA Lawyer back in September 2011. That was a very nice cover.

PS: Well there is no article to accompany the cover. The photo is for serving my term as the President of the San Antonio Bar Association (SABA). I served from August 2010 to August 2011 and I was a board member for ten years prior to that.

BS: How was your term as President of SABA?

BS: What kind of music do you listen to?

BS: Do you have a pet peeve based on what you see from the appellate bench.

PS: Prepare and take the time to proof read your briefs. Do not attempt to cite references to the record that are meant to misinform or defraud the court. Take great pride in your work and be accurate with citations. Also, spell-check your work yourself, do not just depend on the computer to spell check for you, that can lead to more grammatical errors. Also, be respectful and courteous to opposing counsel, your client, and the judges.

BS: What is your favorite food?

PS: Well, even with my Greek heritage, I love Italian food ... bread, pasta, carbs, carbs, I love it.

BS: What is one thing that you really enjoy?

PS: I love my new iPad! I absolutely adore it and highly recommend it!

BS: Are you still Chair of the new Veterans Program?

PS: Oh yes... It is a part of the Community Justice Program that we started in 2001. We will be celebrating the tenth anniversary here soon. However, The Veterans Clinic is only about a year in existence and doing well. I encourage volunteers to come out and take part in one of the clinics.
