## BCWB and Fox Tech Celebrate Law Day

On April 6, 2010, the Bexar County Women's Bar Foundation hosted a luncheon at the Plaza Club for the female law-magnet students at Fox Tech High School. As the students and members of the BCWBF enjoyed a buffet luncheon, Chief Justice of the Fourth Court of Appeals, Catherine Stone translated this year's Law Day theme—Law in the 21st Century: Enduring Traditions, Emerging Challenges—into easily accessible parables. Using everyday examples, such as illegal music downloading and access to life-saving healthcare treatments, Chief Justice Stone helped the students see that their generation will be faced with important legal issues we have not even considered yet.

Prior to the luncheon, students were invited to participate in the Law Day poster contest, depicting their perspective on this year's Law Day theme. A Fox Tech senior, Jon Garcia, was awarded a cash scholarship for his first-place poster, inspired by news stories regarding child abuse. Jon explained his poster is intended to remind us that child abuse is an ongoing legal problem in the 21st Century for San Antonio and Texas as a whole.

After the luncheon, the students stayed to visit with the practicing lawyers. The students asked questions about higher education, work/life balance, compensation, working while going to college, and student loans. Speaking with the women of the BCWB is truly an invaluable opportunity for the Fox Tech students to find out what it is really like to go through law school and practice law in San Antonio. The benefits are also felt by the women of the BCWB, who always enjoy this opportunity to meet San Antonio's next generation of leaders.

### Community Service Committee Corner

This month, an article in the April issue of *Ladies Home Journal* caught my eye. It was about a former elementary school teacher from Boling, Texas, who saw first hand the poverty some of her students lived in and with. She decided to start helping them with something as simple as a new pair of pajamas, one thing many of our kids take for granted, where many of these kids never had new pajamas, if at all. She held the drive to benefit her local Child Protective Services for the children who were taken away from families or brought there for various reasons. It is amazing how something so simple can make such a difference in a child's life!

So this month, with the help of *Ladies Home Journal*, I have three ways for you to help make life just a little brighter for a child in need:

- 1. Collect suitcases, bags and backpacks and donate them to our Local Child Protective Services. Many kids they service carry their belongings in trash bags.
- 2. The organization "Walk Me Home" hosts a 5 K event nationwide to help raise money for foster-care associations visit walkmehome.org to find out about a fund-raiser near you or maybe, just maybe, we have some of our own membership that would be willing to go out on a limb to help set up one here?
- 3. Mentor or tutor a child who has been placed in foster care. You can do it virtually through the online program vMentor. You can learn more about this program at casey.org/getinvolved.

And there you have it. Three relatively simple ways to make a difference in a child's life.
