#### A Girl's Gotta Eat

Although it's much more fun to write about and relive fancy dinners and the newest, hottest restaurants, lately, my focus has turned much more toward the daily grind and getting something relatively healthy on the table for dinner for my family of four, including a preschooler and a toddler. This is no easy feat, considering the very short window of time between when I pick the kids up at day care around 6:00 and when the youngest goes to bed around 7:30. I can easily understand the temptation to just drive through somewhere and call it a day. On my better days, I try one of these ideas.

I love Greenling meal kits. Greenling (greenling.com) is an Austin-based company that delivers organic and local grocery products to your front door. Sure, they're more expensive than HEB, but you can't beat the convenience of having groceries delivered two days per week. But even better than their amazing produce, meats, and dairy, is their already-prepped and portioned meal kits, most of which can go from fridge to table in about 20 minutes since you don't have to slice, dice, wash, or otherwise prepare any of the ingredients. And the website has nutrition information for nearly every meal kit, taking the guesswork out of what you're feeding the family.

There are family favorite meal kits for pasta primavera, French bread pizzas (a great hands-on activity for the kids to help with assembly), and broccoli rice and cheese casserole. We also enjoy the garlic ginger stir-fry with cashews and Greek stuffed portobello mushrooms, though those are less popular with the kids. It's also convenient to toss one of the slow-cooker meal kits together in the morning and have dinner waiting when you get home. Plus, they have meal kits for special diets, including paleo, vegan, vegetarian, Engine 2, and Love Life. They even have breakfast meal kits that make you look like a domestic goddess without having to get up two hours before the rest of the family (check out the berry pecan French toast casserole)!

When I can't even spare the 20 minutes to whip up a Greenling meal kit, we've also had great success with takeout from a couple of possibly overlooked spots: Zoe's Kitchen and Chipotle. Zoe's Kitchen (<u>zoeskitchen.com</u>) has two San Antonio locations, one near I-10 and Huebner and one on Basse in Lincoln Heights. Even if you visit them for lunch, you may not have noticed their "Dinners for Four." What works for us is the combo kabob dinner, which includes eight skewers (mix and match chicken, beef, or shrimp with zucchini), two family-sized sides (try their mayo-free potato salad and roasted veggies for dairy-free options), and pita bread. It's more than enough for our young family, but I could see needing a bit more if you have hungry teenagers. It's easy to place your order online and pick up on your way home.

And finally, there's Chipotle. You're probably familiar with their burritos, bowls, and tacos (which you can make pretty healthy by omitting cheese and sour cream), but we have been very pleased with their kids' meals. For under \$5, the kids get a small quesadilla (with or without meat), small sides of rice and beans, a small bag of chips, and organic milk or juice. You can also get a kids' build-your-own taco kit with crispy or soft taco shells, three ingredients (including meat or guacamole), chips, and organic milk or juice. For a grown-up change of pace, we like the salads with the chipotle honey vinaigrette. In less than 10 minutes, you can have a relatively healthy, crowd-pleasing dinner ready for the table.

Of course, when all else fails, just order pizza!



I've had a great six months. I look forward to an even better second-half of the year!


### **WLA Update**
