### Judicial Spotlight: Judge Antonia "Toni" Arteaga

### Q: Tell us about your history as an attorney and then a judge.

In 2008, I became the first woman elected to the historic 57th District Court which was created in 1899. I graduated from the University of Texas in Austin with a Bachelor of Arts in Government and Sociology, and earned my law degree from St. Mary's University School of Law. However, I was first sworn in as a judge in 2006. Mayor Phil Hardberger twice appointed me as an Associate Judge and Magistrate for the City of San Antonio. By the way, my first judicial Oath of Office took place at my daughter's one -year birthday party while standing in front of Crayola decorations (long story).

As an attorney in private practice, my caseload consisted of both family and criminal law. Soon into my career I gained a reputation as a trial attorney. When I closed my private practice to take the bench, I had tried almost 70 jury

trials to verdict. Personally, I took great satisfaction in helping those who so desperately needed assistance.

### Q: Did you always know you wanted to be a judge? What inspired you to make this decision?

No. I always knew I wanted to be an attorney and never seriously considered being a judge or elected official until being asked by colleagues. But it was my family that inspired me to make the decision to serve.

In the summer of 2008, a group of my colleagues approached me and asked me to seek the nomination to fill a Democratic vacancy on the ballot. I declined because of my concerns for meeting the demands of being mother to my young children and running a successful campaign. My daughter was only three, and my son had just turned a year old. However, my colleagues wouldn't take no for an answer and asked me once more to consider running. I again politely declined, but discussed this conversation with my father-in-law and that's where the inspiration to serve as judge was born.

With his encouragement, I began researching and making calls to my professional mentors asking for their input. Despite their positive feedback, I knew it would be incredibly difficult to campaign with two children under the age of three, but then my sisters-in law sealed the deal, so to speak, when they came to me and said basically, "You need to do this. Bring us the babies and don't worry about a thing."

### Q: What has been the most surprising thing about being a judge?

The most surprising thing about being judge is possibly also the greatest thing about being a judge – the other judges with whom I serve. There are 13 other people who could possibly understand what a day on the bench is truly like. (con'd on p. 5)

I wish I could elaborate. My judges are incredible human beings. Yes, believe it...we are human!

### Q: Something I didn't expect when I ran for the 57th?

What is the space limitation for this article? There is so much. Personally, I didn't expect to be recognized as "Judge Arteaga" at my HEB. Now, I at least attempt to dab on some mascara and lip gloss before leaving the house. Professionally, I didn't expect the pressure — perhaps self-imposed. I don't mean the pressure of a horrific child abuse case, gut-wrenching custody fight or even the stresses of a month long trial resulting in a \$57 million verdict with news media in the courtroom. I can handle that kind of pressure. However, I didn't expect to feel such an incredible responsibility as a role model, especially to other women. As you know, young women often face greater demands and expectations both personally and professionally. As a (still fairly) young professional woman in a very visible position, I feel I'm duty-bound to set a high standard by which other young woman can benefit. It's difficult to explain (in a politically correct manner) and perhaps would better expressed in a one-on-one conversation.

### Q: Excluding the law- what are you passionate about?

My family. I covet my personal time, and make no apologies when it comes to making time for my children, their school events, doctor's appointments, etc.

### Q: Tell us a few of your favorite things. Book? Movie? Restaurant? Pastime?

Currently, my favorite book is The Help. This book truly helped me, no pun intended, get through some very long training runs when preparing for my first half-marathon.

I love disaster flicks, like *The Poseidon Adventure* (the original one) and great chick-flicks, like The Notebook.

My favorite restaurant all depends on the occasion. Daily favorite — El Mirador. If I need to meet a campaign supporter — Paesano's. On Date Night - Joe's Crab Shack. Celebrating report cards — Incredible Pizza on West Avenue.

Pastime: an interest or activity that one pursues in his/her spare time. NOT APPLICABLE

### Q: If you could give one piece of advice to up and coming female attorneys, what would it be?

Find a mentor, more than one, whom you trust and keep in regular, if not daily, contact with him/her.
