and and for those that couldn't join Zoom live, the free webinar was live-streamed on YouTube, and the video posted to the BCWB website.

Even though many of our events have been cancelled for the forseeable future, the BCWB is going to continue to work to facilitate connection with more free webinars and maybe even some smaller remote round table discussions. We will also continue to bring you current information on governmental and court orders, policies and procedures. The BCWB is also exploring ways to continue to mentor the students of St. Mary's University School of Law through remote sessions.

The LEAD program isn't letting social distancing stop their progress in empowering and assisting women attorneys to achieve their highest levels of success. LEAD will be utilizing technology to make their Vision Board Event and other events happen remotely, and will continue to bring the 2020 class exciting curriculum and opportunities for growth.
