Judicial Spotlight Judge Juage Veronica Vasquez

Judge Veronica Vasquez was elected to the bench of Bexar County Probate Court No. 2 in 2018. Her career experience ranges from working as a legislative aide, as a lawyer specializing in elder law and probate, and as a department director and managing staff attorney at Catholic Charities in San Antonio. Despite her busy schedule, Judge Vasquez took the time to discuss her career and mentors, the importance of sisterhood, and her calling to help and protect those in our society who are the most vulnerable.

Where did you go to law school, and did you know you wanted to be a judge when you were in school?

I graduated from the University of Texas School of Law and the University of Texas for undergrad. I bleed burnt orange. I did not know I wanted to be a judge. My sole reason for attending law school was to help people. I interned my last semester of undergrad at the Texas Civil Rights Project. It was there that I began to understand the impact lawyers have on people's lives. It was at this time that I decided I wanted to go to law school to help people.

Who were/are your mentors, and how did they impact you?

I am blessed to have many mentors over the years. One of my mentors is Senator John Whitmire. After undergrad, I worked for the Senator in both his Houston and Austin office. I learned a lot from him about diplomacy and the art of hearing all sides of an issue. When running for this office, he supported me and gave me valuable advice. I consider him a lifelong mentor. I also have a mentor named Sarah Buel. She was my professor at UT Law and taught domestic violence and the law. She was a domestic violence survivor and one very resilient and smart person. She taught me that we must use our voice to advocate for those that cannot speak for themselves. We still keep in touch. Finally, my other mentor is Pat Jasso. Pat Jasso is a fierce advocate for women's equality and she's not afraid to speak up. I admire people like that. She encouraged me to run and has pushed me to be bold.

Judicial Spotlight cont.

What is one of the biggest challenges you have faced in your career, and what skills did you utilize to overcome it?

I believe one of my biggest challenges I have faced in my career is dealing with sexism - Yes, it exists! When first starting my career, I had not experienced (overt) sexism. I have been mistaken for the legal assistant, received brash comments, and had my opinions and thoughts dismissed because I am a woman. At one of my previous law firms the men of the firm would fly to Vegas and bond - women were never, if rarely ever, invited. I believe this gave an unfair advantage to my male colleagues when we were competing for partner. I did bring it to my bosses' attention, but nevertheless, the Vegas trips continued. For other reasons, I ultimately left the firm. These challenges in some ways are a blessing. It has made me more aware of who I am as a female attorney, and brought me closer to my female colleagues. I have mentored young women in the legal field and will continue to do so. We need that sisterhood!

What was your career path before being elected, and how did your experience prepare you to be a judge?

I worked for a State Senator John Whitmire before law school, during law school, and after law school. In this position I worked with the public to address their needs. I also observed great campaigning, which helped when it was my turn to campaign. My first legal job was as an ad valorem tax attorney (property tax attorney). This position actually helped me in the field I am in today because probate has a lot of property issues as well. I was also appointed by Harris County Commissioners to be a Game Room Hearing Examiner. I heard appeals for revocations and suspensions of licenses for game rooms in the City of Houston and Harris County. Being a hearing examiner prepared me for the role I am currently in. I knew what kind of Judge I would make if elected and I knew it was the right calling for me after this position. I also had my own private practice in probate law and then worked for Catholic Charities as the Director of the Guardianship and Probate Department. I enjoyed the position at Catholic Charities; it helped me understand the great need there is for low-cost legal services. I continue to value the need for low cost/ pro bono legal services, and am currently the Co-Chair for the CJP.


What has been your greatest learning experience on the bench so far?

Probate court is a very busy court; every day I learn something new.

What is the most rewarding part of being a judge?

Protecting people. Probate court hears a lot of Adult Protective Services cases and guardianship cases. In guardianship cases, loved ones try to obtain guardianship over incapacitated family members. Unfortunately, I also see a lot of cases of elder abuse, neglect and exploitation. These individuals are the most vulnerable in our society. By granting guardianships, the court is helping to protect these individuals.

Thank you, Judge Vasquez, for your public service, dedication to help others, and support of the BCWB. We are so inspired by you. Because of women like you, the future of women in the law is certainly bright!


